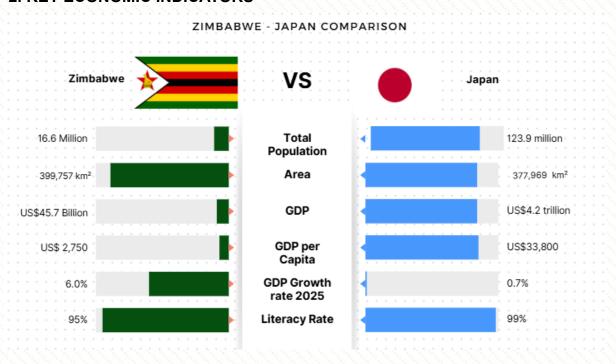




1. JAPAN OVERVIEW

Japan is an island country in East Asia. Located in the Pacific Ocean off the northeast coast of the Asian mainland, it is bordered on the west by the Sea of Japan and extends from the Sea of Okhotsk in the north to the East China Sea in the south. The Japanese landscape is rugged, with more than four-fifths of the land surface consisting of mountains.

3. ZIMBABWE – JAPAN TRADE

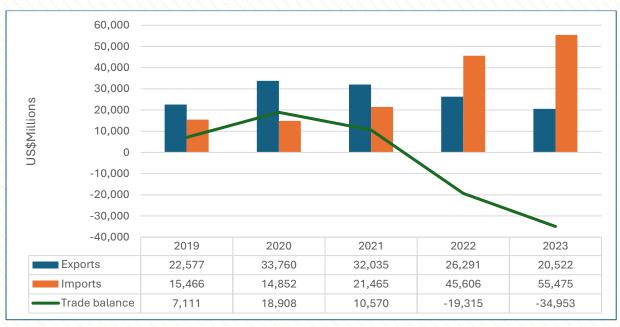


Figure 1: Zimbabwe Japan Trade





As shown in Figure 1 above, the trade imbalance for Zimbabwe with Japan has grown over the five-year period 2019 to 2023, from US\$7.11 million in 2019 to US\$34.95 million in 2023.

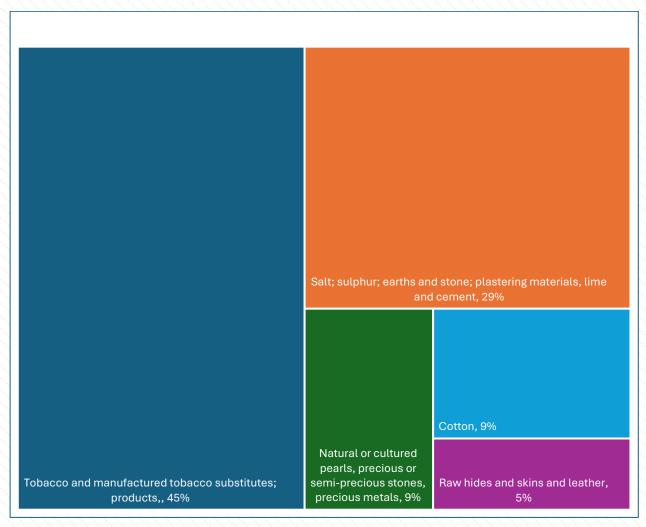


Figure 2: Products exported by Zimbabwe to Japan

In terms of exports, Zimbabwe's exports to Japan were at the highest in 2020 recording US\$33.76 million and lowest in 2019 at US\$22.58 million. The main products exported were tobacco, earth and stones, natural or cultured pearls, cotton and raw hides as shown in Figure 2.

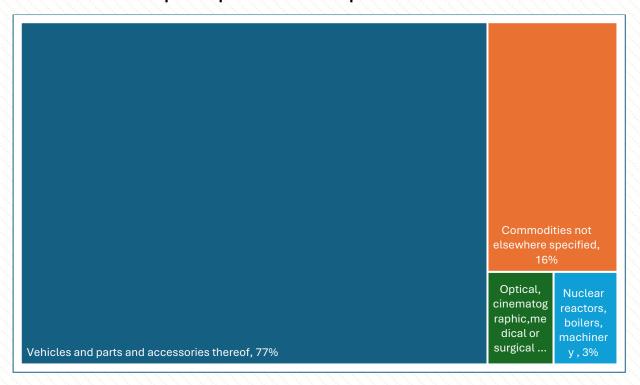


Figure 3: Products imported by Zimbabwe from Japan

Zimbabwe's imports from Japan grew by 259% from US\$15.47 million in 2019 to US\$55.48 million in 2023. Figure 3 shows the main products imported which were vehicles and accessories, optical for medicals or surgical and machinery among others.

3.3 Zimbabwe's Export Potential to Japan

Zimbabwe has an unrealized export potential in Japan amounting to US\$3.6million (refer to Annexure 3). The products with greatest export potential from Zimbabwe to Japan are Ferrochromium, >=4% carbon, Mineral substances, n.e.s. and Oranges. Zimbabwe has the highest supply capacity in Raw hides & skins of reptiles. Copper ores & concentrates are the products that have the strongest demand potential in Japan.

4. JAPAN'S TRADE WITH THE WORLD

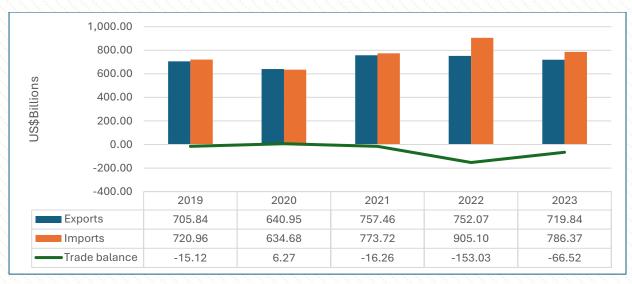
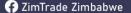


Figure 4: Japan's Trade with the World









As shown in Figure 4 above, over the five-year period 2019 to 2023, Japan recorded a positive trade balance of US\$6.27 billion with the World in 2020, with the other years being negative.

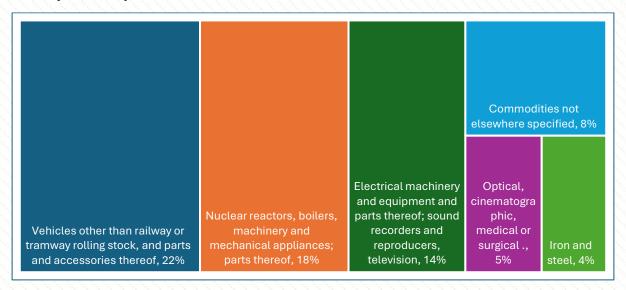


Figure 5: Japan's Exports to the World

In terms of exports, Japan's exports to the World averaged US\$700 billion during the same period with the main products exported being vehicles and parts, machinery and mechanical appliances, and electrical machinery and equipment among others as shown in Figure 5.

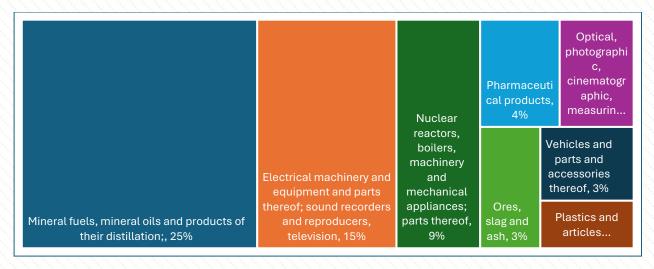


Figure 6: Japan's Imports from the World

Over the same period, Japan's imports from the World were the highest at US\$905.10 billion in 2022 and lowest at US\$634.68 billion in 2020. Figure 6 shows the main products imported which were mineral fuels, ores and plastics, among others.

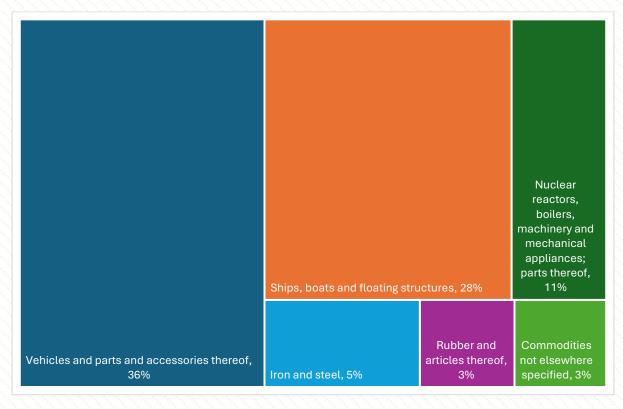


Figure 8: Products Exported by Japan to Africa

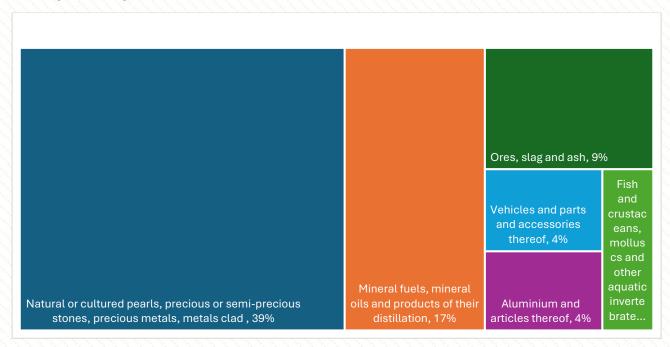


Figure 9: Products Imported by Japan from Africa

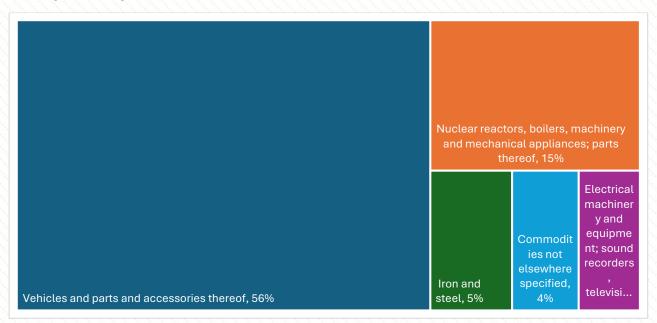


Figure 11: Japan's Exports to SADC

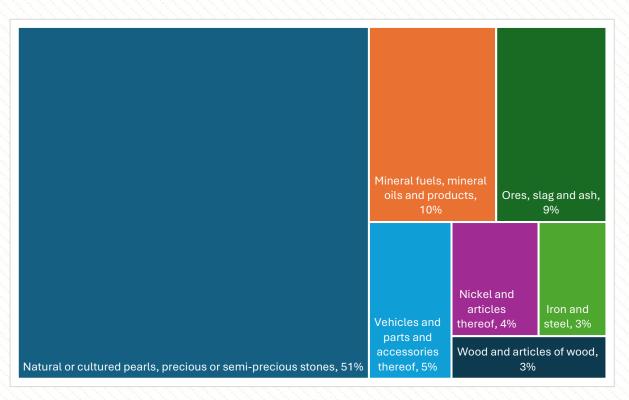
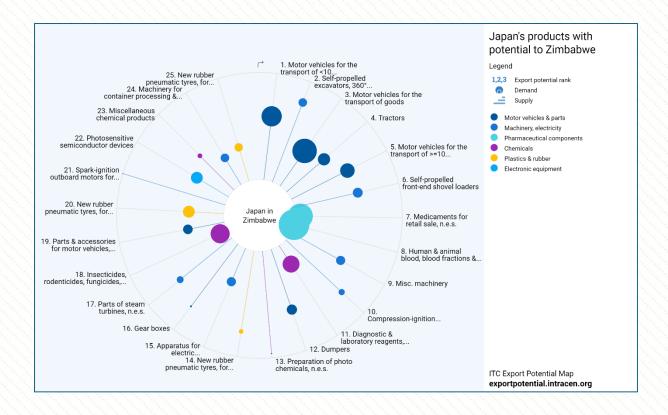


Figure 12: Japan's Imports from Africa

7. JAPAN'S EXPORT POTENTIAL IN ZIMBABWE



The products with greatest export potential from Japan to Zimbabwe are Motor vehicles for the transport of <10 persons, self-propelled excavators, 360° rotating superstructure and motor vehicles for the transport of goods. Japan has the highest supply capacity in Spark-ignition outboard motors for marine propulsion. Human & animal blood, blood fractions & immunological products is the product that has the strongest demand potential in Zimbabwe.

8. ZIMBABWE'S TRADE OPPORTUNITIES IN JAPAN

8.1 Growing Demand for Organic and Fair-Trade Products

Japanese consumers are increasingly seeking organic and ethically sourced goods. Zimbabwe can capitalize on this trend by exporting organic agricultural products such as coffee, tea, and fruits. Japan imported coffee and tea amounting to US\$1.724 billion in 2023 from the World with source countries from Africa being Ethiopia, Tanzania, Kenya and Rwanda. Edible fruits sourced from Africa amounted to US\$55.615 million in 2023 with source countries being South Africa, Egypt and Morrocco. In these identified products, Zimbabwe is yet to start exporting to Japan.

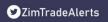
8.2 Cotton and Textiles

Zimbabwe's high-quality cotton can meet Japan's demand for raw materials in the textile and fashion industries. Japan imports raw cotton, processes it into value-added









products, and exports high-quality yarns, fabrics, and finished goods to international markets, leveraging its expertise in precision manufacturing. Japan imported cotton worth US\$423.466 million from the World in 2023 with Africa contributing US\$4.146 million. Zimbabwe was the main source country from Africa with US\$1.775 million representing 42%. In order to benefit from the close economic ties between the two countries, Zimbabwe should negotiate for cotton value addition investments by Japanese companies in the sector.

9. ISSUES TO CONSIDER

9.1 Stringent Quality and Safety Standards

Japan imposes strict regulations on imports, especially for food and agricultural products, requiring Zimbabwean exporters to comply with rigorous quality, safety, and phytosanitary standards.

To overcome this challenge, it is essential to: Provide training and support to exporters on meeting Japanese quality and safety standards. Strengthen bilateral trade agreements to address trade barriers and simplify export procedures.

9.2 High Transportation Costs

The geographical distance between Zimbabwe and Japan contributes to increased shipping costs, which may reduce competitiveness. This is compounded by Zimbabwe being a land-linked country which can delay shipments and affect product quality.

To overcome this challenge, it is essential to: Take advantage of Zimbabwe's participation at OSAKA EXPO 2025 by highlighting opportunities for collaboration with the Japanese in developing Zimbabwe's infrastructure, including transport, energy, and technology.

9.3 Limited Diversification of Export Products

Over-reliance on tobacco and a few other commodities limits Zimbabwe's ability to fully leverage on the Japanese market.

To overcome this challenge, it is essential to: Use platforms such as OSAKA EXPO 2025 to present opportunities to attract Japanese investors into Zimbabwe's agricultural and manufacturing sectors. Also, introducing unique Zimbabwean products such as crafts and organic coffee to the Japanese market.

9.5 Market Entry Barriers

Lack of familiarity with the Japanese market, language barriers, and complex import processes can pose challenges for Zimbabwean businesses.

To overcome this challenge, it is essential to: Strengthen bilateral trade agreements to address trade barriers and simplify export procedures as well as explore joint ventures and partnerships with Japanese firms for better market access and knowledge transfer.





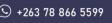




10. CONCLUSION

Strengthening trade ties between Zimbabwe and Japan presents significant opportunities for mutual economic growth. Zimbabwe, which is endowed with abundant natural resources and a strategic geographical position, can leverage its exports to meet Japan's demand for high-quality raw materials such as cotton and agricultural products. Conversely, Japan's advanced technological capabilities and expertise in industrial production offer Zimbabwe valuable prospects for technology transfer, capacity building, and industrial modernization.

To enhance trade relations, Zimbabwe must focus on meeting Japan's stringent quality and regulatory standards, investing in value-added production, and promoting sustainability and traceability in its supply chains. Diversifying export portfolios, improving logistics infrastructure, and fostering strong bilateral trade agreements are critical steps to overcoming challenges such as distance, high transportation costs, and competition from other exporters.

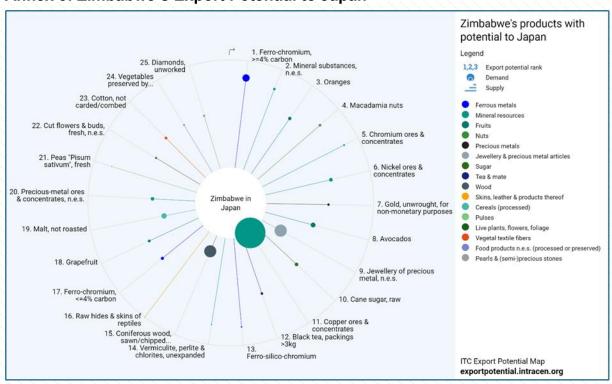
